



Trinity GAP Club Adoption Contract

This is a legal binding contract between Trinity G.A.P Club and the Adopter _____ who is fully identified below. The Adopter wishes to adopt the companion animal identified in this contract from Trinity G.A.P Club. In return for the fee, in the sum of \$_____ Trinity G.A.P Club agrees to transfer ownership of the animal to the Adopter upon completion of all requirements stated herein. The Adopter by his/her signature acknowledges that he/she has read and understands the following:

1. Adopter will provide the animal humane care, appropriate grooming, proper food, water, shelter, exercise, and a safe environment.

2. Adopter agrees never to allow the animal to be used for purposes of medical experimentation or research. Adopter agrees that the animal will not live caged, abused, or used as a work animal. Adopter acknowledges that the animal is being adopted for companionship only. Initial: _____

3. Adopter agrees to take the animal to a veterinarian for routine examinations, to keep the animal free of parasites including the use of heartworm preventative, properly vaccinated (including yearly or tri- yearly rabies vaccinations) and to provide immediate care for the animal in the event of illness or injury. 4. Adopter agrees to return the animal to Trinity G.A.P Club if he/she is unable and/or unwilling to pay for the expense of treatment by contacting Steffenie Vela at 817-689-4740. Adopter agrees to allow any agent of Trinity G.A.P Club to remove the animal from the adopter's premises if the animal is not receiving proper care, such as the animal is being abused, neglected or being used for any purpose other than companionship. 5. Adopter agrees to return the animal to Trinity G.A.P Club in the event the adopter is unable and/or unwilling to care for the animal by contacting Steffenie Vela at 817-689-4740. This contract is nontransferable. Ownership may not be transferred to another party without the permission of Trinity G.A.P Club. Initial: _____

6. Adopter agrees NEVER to alter the animal for cosmetic or convenience purposes (i.e. docking tail, ear cropping). Initial: _____

7. Adopter agrees to comply with all state laws pertaining to ownership of the animal, including those laws requiring licensing of the animal. Adopter agrees to redeem the animal promptly (within 24-48 hours) if the animal is picked up by the animal control agency. If Adopter cannot redeem the animal, ownership will revert to Trinity GAP Club. Initial: _____

8. Adopter acknowledges that any breach of paragraphs 1 through 7 by the adopter constitutes grounds for Trinity G.A.P Club to rescind this contract, in which case ownership of the animal will revert to Trinity G.A.P Club. Adopter

agrees to pay the court costs and reasonable attorney fees incurred by Trinity G.A.P Club from enforcing this contract.

The adopter agrees that Trinity G.A.P Club has made no guarantees regarding the nature, disposition, or health of the animal. The adopter agrees to assume all risk and responsibility of ownership of the animal once the animal is in the possession of the adopter. The adopter agrees to defend and indemnify Trinity G.A.P Club against any and all claims for damages, including claims of property or personal injury allegedly caused by the animal, arising out of the adopter's ownership of the animal. If the adopter violates any term of this contract, including misrepresentation to Trinity G.A.P Club or writes an insufficient adoption fee check, Trinity G.A.P Club can request the return of the animal, or without notice or liability, enter the adopter's property to repossess that animal.

**Insufficient funds fee is \$50.00

Adoption Rates Adoption fees from the Euless Animal Shelter are: male dogs & cats = \$60, female dogs and cats = \$85. All male puppies under 4months \$125, all female puppies under 4months \$150 to cover all puppy vaccine series, deworming, and neutering. Adoption fees for animals in foster: male dogs = \$100, female dogs = \$125 (this includes heart worm testing in addition to the vaccines and neutering). Cats in foster are \$60 for males and \$85 for females. If an animal has a different adoption fee, it will be listed on their specific page.
